The Policy

This privacy policy governs your use of the software application Artory App ("Application") for mobile devices that was created by the Artory Partners. The Application is intended as a 'What's On' listing application for culture in Plymouth that also earns you Art Miles®* to exchange for exclusive offers. By setting your preferences you get a personal guide to events and cultural happenings in Plymouth. You can see what other people are recommending, what's nearby you now, or search via date, venue or event.

User Provided Information

The Application obtains the information you provide when you download and register the Application. Registration with us is optional. However, please keep in mind that you may not be able to use some of the features offered by the Application unless you register with us.

When you register with us and use the Application, you generally provide (a), email address, password, user name, gender, Y.O.B, postcode, employment status, educational status and household income; (b) transaction-related information, such as where you Check-In, respond to any offers, or download or use applications from us; (c) information you provide us when you contact us for help; (d) information you enter into our system when using the Application, such as feedback

We may also use the information you provided us, to contact you from time to time to provide you with important information, required notices and service updates.

Automatically Collected Information

- with our trusted services providers who work on our behalf, do not have an
 independent use of the information we disclose to them, and have agreed to

- If i-DAT, Plymouth University is involved in a merger, acquisition, or sale of all or a portion of its assets, you will be notified via email and/or a prominent notice on our website of any change in ownership or uses of this information, as well as any choices you may have regarding this information.

What are my opt-out rights?

You can stop all collection of information by the Application easily by uninstalling the Application. You may use the standard uninstall processes as may be available as part of your mobile device or via the mobile application marketplace or network. Data Retention Policy, Managing Your Information

We will retain User Provided data for as long as you use the Application and for a reasonable time thereafter. We will retain Automatically Collected information for up to 5 years and thereafter may store it in aggregate. If you'd like us to delete User Provided Data that you have provided via the Application, please contact us at contact@artory.co.uk and we will respond in a reasonable time. Please note that some or all of the User Provided Data may be required in order for the Application to function properly.

Security
